### MEMORANDUM OF UNDERSTANDING (MoU)

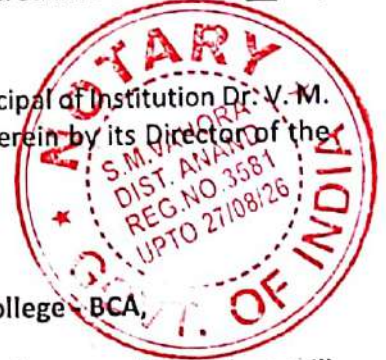

WHEREAS:

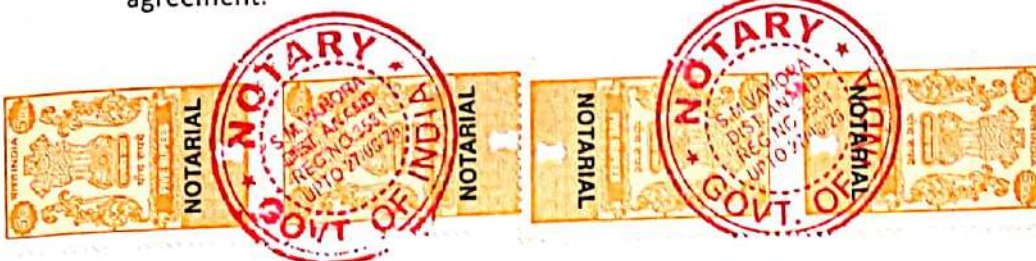
- A) First Party is a Higher Educational Institution named: Anand Commerce College - BCA,
