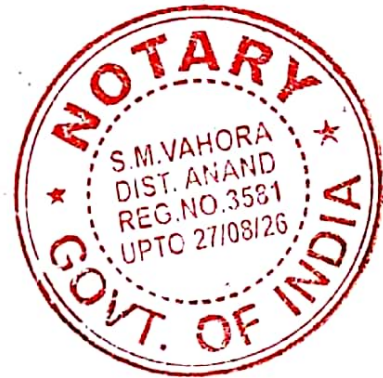

ANAND COMMERCE COLLEGE the First Party represented herein by its Principal of institution Dr.V.M.Vanar, and M.D.SHAH COMMERCE & B.D.PATEL ARTS COLLEGE, MAHUDHA the second party, and represented herein by its Principal Dr. K. S. Dave.

WHEREAS:

- A) First Party is a Higher Educational Institution named: ANAND COMMERCE COLLEGE.
- B) First Party & Second Party believe that collaboration and co-operation between themselves will promote more effective use of each of their resources, and provide each of them with enhanced opportunities.
- C) The Parties intent to cooperate and focus their efforts on cooperation within area of Skill based and Value based Training, Education, celebration of festivals meditation and yoga workshops, seminars, conferences and expert lectures.

NOW THEREFORE, IN CONSIDERATION OF THE MUTUAL PROMISES SET FORTH IN THIS MOU, THE PARTIES HERETO AGREE AS FOLLOWS:

CLAUSE 1 CO-OPERATION

- 1.1 Both Parties are united by common interests and objectives, and they shall establish co-operation.
- 1.2 First Party and Second Party co-operation will facilitate effective utilization of the intellectual and moral capabilities.
- 1.3 The parties shall co-operate with each other and shall act with mutual responsibilities.



CLAUSE 2 SCOPE OF THE MOU

In particular, this MOU is intended to

- 2.1 Inviting M.D.SHAH COMMERCE & B.D.PATEL ARTS COLLEGE, MAHUDHA teaching staff and ANAND COMMERCE COLLEGE Teaching staff for delivering expert talk to the students and thereby sharing knowledge with college students.
- 2.2 To organize workshops/seminars/conferences in collaboration with the M.D.SHAH COMMERCE & B.D.PATEL ARTS COLLEGE, MAHUDHA and ANAND COMMERCE COLLEGE.
- 2.3 To allow participation of staff members/employees of both the organization in workshops/seminars/conferences.
- 2.4 To arrange Training and Activities on Value Education for the students and employees.
- 2.5 To provide guidance to the students and employees for Personality Development, Managerial skills , Communication Skills, celebration of festivals meditations, and yoga .
- 2.6 Any other activity of mutual interest.

CLAUSE 3 VALIDITY

3.1 This Agreement will be valid until it is expressly terminated by either Party on mutual agreement and terms and conditions.

CLAUSE 4 RELATIONSHIP BETWEEN THE PARTIES

4.1 It is expressly agreed that First Party and Second Party are acting under this MOU as independent contractors, and the relationship established under this MOU shall not be construed as a partnership.

4.2 Both ANAND COMMERCE COLLEGE and M.D.SHAH COMMERCE & B.D.PATEL ARTS COLLEGE, MAHUDHA jointly announce that the purpose of this MOU will not have any financial or legal bindings.
