## **CLAUSE 2 SCOPE OF THE MOU**

## In particular, this MOU is intended;

- 2.1 To invite experts from industry for delivering expert talk to the students and thereby sharing knowledge with college students
- 2.2 To arrange internship /training (for the students of the college)
- 2.3 To organize workshop/seminar/conferences in collaboration with the industrial units
- 2.4 To allow participation of staff members/employee of both the organization in workshop/seminar/conferences
- 2.5 To arrange placement for the students
- 2.6 To develop entrepreneurial mindsets among the students and encourage them for start-up
- 2.7 To invite participation of experts from industry in curriculum development
- 2.8 To arrange visits of students and staff members to gain practical knowledge
- 2.9 Any other activity of mutual interest

#### **CLAUSE 3 VALIDITY**

3.1 This Agreement will be valid until it is expressly terminated by either Party on mutually agreed terms, during which period, the Second Part.

### **CLAUSE 4 RELATIONSHIP BETWEEN THE PARTIES**

4.1 It is expressly agreed that First Party and Second Party are acting under this MOU as independent contractors, and the relationship established under this MOU shall not be construed as a partnership.
