

WHEREAS:

CLAUSE 1 CO-OPERATION

CLAUSE 2 SCOPE OF THE MOU

In particular, this MOU is intended to

- 2.3 To allow participation of staff members/employees of both the organization in workshops/seminars/conferences.

CLAUSE 3 VALIDITY
