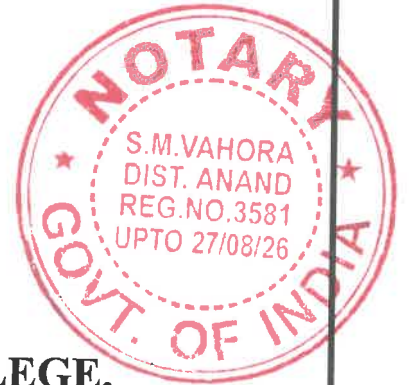

3.1 This Agreement will be valid until it is expressly terminated by either Party on mutual agreement and terms and conditions.


CLAUSE 4 RELATIONSHIP BETWEEN THE PARTIES
